

## **ARTICLE 10. TABLE OF PERMITTED USES** (Revised. 11-12-09)

Districts in which particular uses are permitted as a use-by-right are indicated by "P." Uses not specifically listed in the Table of Permitted Uses are prohibited.

Districts in which particular uses are permitted as a conditional use upon approval of the City Board of Aldermen are indicated by "C." See the Table of Regulations for Conditional Uses, Section 12-18, for details of each conditional use.

Districts in which particular uses are prohibited are indicated by a blank.

Any land use listed in the Table of Permitted Uses that incorporates or utilizes a drive-in facility must have its site design plan and proposed traffic circulation and parking plan approved by the City of Southport. Those plans must be approved prior to construction of the drive-in facility.

Minimum zoning district area (acreage) requirements are defined in Article 11, Table of Area, Yard, Density, and Height Requirements.

## Section 10-1: Notes to the Table of Permitted Uses

Note 1. The Standard Industrial Classification Codes indicated in the Table of Permitted Uses are for reference purposes only, and do not mean that all uses under a specified code heading as provided in the Standard Industrial Classification Manual are permitted or conditional uses in the applicable zone.

Note 2. Land Use Within the Planned Unit Development. All uses listed in the Table of Permitted Uses as a use-by-right in the PUD district shall be specified to be developed on certain sites within the PUD district at the time of the approval of the preliminary plan. Commercial activities shall be permitted only as prescribed by Section 14-6.

Note 3. Industries. The following industrial uses shall not be allowed:

- (A) The manufacturing, processing, fabrication, and/or bulk storage of acetylene gas (except for use on premises), ammunition, explosives, fireworks, gunpowder, jute, or matches;
- (B) The manufacturing, processing, and/or fabrication of acids (except non-corrosive acids), ammonia, ammonium nitrate, animal byproducts, bleaching powder, cellulose, chlorine, creosote and creosote treatment, detergents, enamels, lacquers, linoleum, oilcloth, paints, paper pulp, pigments, lime, plastic, rubber (except tire recappers), soaps, tannery products, turpentine, varnishes, whiting and/or wood fillers, and environmentally hazardous material. The fabrication of plastics is exempt from this prohibition.

Note 4. Accessory Uses. In the O-I district, there shall be no open storage as an accessory use. In the LI district, open storage as an accessory use shall be permitted, provided it is enclosed by a fence not less than six (6) feet in height. Permanent residential occupancy shall be allowed as an accessory use only as an accessory dwelling residential or an accessory dwelling commercial. There shall not be more than two (2) accessory structures or uses per lot in the R-10, R-20, MF, MH, PUD, O-I, CBD, BD and HC districts. Swimming pools as an accessory use in R-10, R-20, MF, MH, O-I or PUD districts shall be enclosed by protective fencing not less than five (5) feet in height and should be setback five (5) feet from the existing property line. Automatic teller machines shall be allowed as an accessory use in the O-I, PUD, BD, and HC districts.

Note 5. Dry Cleaners. Screening and filtering devices shall be used to prevent the emission of smoke, dust, fumes, odors, or steam into the atmosphere.

Note 6. Storage of Flammables. The permitted use of bulk storage of bottled gas (distribution) or storage of flammables in the City of Southport Fire District shall be regulated by the City of Southport Building Code Regulations.

Note 7. Jails. Jails shall not be site within two hundred (200) feet of any existing church, school, or day care facility. The jail shall be fenced and screened as provided in the case of salvage operations and junkyards except that this requirement may be modified or waived by the Administrator upon the showing by the operator that a modification or waiver is needed for security reasons.

Note 8. Nursing and Personal Care Facility. A nursing and personal care facility, nursing home/convalescent center, or residential care facility cannot be located in an area which would be flooded by either a slow or fast moving Category 1 or 2 hurricane. Such areas are identified by the U.S. Army Corps of Engineers Sea Lake Overlaid Surge from Hurricanes (SLOSH) maps.

Note 9. Skirting and Curtain Wall Requirements for Manufactured Homes. All single-wide manufactured homes to be placed within Southport's planning and zoning jurisdiction shall have skirting placed around the base prior to the issuance of a Certificate of Occupancy. Double-wide manufactured homes to be placed within Southport's planning and zoning jurisdiction shall have a curtain wall constructed around the base within 90 days from the date the home is placed on a lot. For both single- and double-wide manufactured homes, one row of ventilation ports, 8-inch by 16-inch, shall be provided every ten feet, and one access opening with a door that is between 18 inches and 42 inches in height and between 24 inches and 60 inches in width. All existing manufactured homes within Southport's planning and zoning jurisdiction prior to the effective date of this provision which have no skirting or curtain wall shall be required to have skirting installed within 18 months following adoption of this Ordinance. All existing manufactured homes within Southport's planning and zoning jurisdiction prior to the effective date of this provision having a continuous uniform enclosure around the base which serves as skirting shall be considered nonconforming, and will be exempt from the specific requirements of this note. All skirting performed after the effective date of this amendment will be done in accordance with section 47.7 of the State of North Carolina Regulations for Manufactured/Mobile Homes 1995 edition.

Note 10. Electrical Service Requirements for Manufactured Homes. All manufactured homes to be placed within Southport's planning and zoning jurisdiction shall have electrical service within 90 days from the date the home is placed on a lot. Manufactured homes left on a lot longer than 90 days will be considered in storage, in violation of this Ordinance, and subject to Section 13-2 of this Ordinance.

Note 11. Manufactured Home Parks. If the owner of a manufactured home community (which consists of at least five manufactured homes) intends to convert the land to another use, the landowner must give each owner of each manufactured home notice of the intended conversion at least 180 days before the home owner is required to vacate and move, regardless of the term of tenancy.

Note 12. Modular Homes. The following construction and design standards apply to modular homes manufactured after January 1, 2004:

- (A) The pitch of the roof for homes with a single predominant roofline shall be no less than five (5) feet rise for every twelve (12) feet of run.
- (B) The eave projections of the roof shall not be less than ten (10) inches (excluding roof gutters) unless the roof pitch is 8/12 or greater.
- (C) The minimum height of the first story exterior wall must be at least 7 feet 6 inches.
- (D) The materials used in and the texture of the exterior must be compatible in composition, appearance, and durability to the materials commonly used in the exteriors of standard residential construction.
- (E) The modular home must be designed to require foundation supports around the perimeter. These may be in the form of piers, piers and curtain walls, piling foundations, perimeter walls, or another type of approved perimeter support.

Note 13. Recreational Vehicles. Recreational vehicles occupied for human habitation and intended for permanent residential use must be placed in an approved manufactured home or recreational vehicle park. However, temporary residential use may occur in cases where the recreational vehicle is secondary to a primary residential use, and when construction or repair of a single family home occurs. Two general restrictions for either temporary residential use shall apply, as well as specific restrictions and limitations for each. The general restrictions and limitations are as follows: (1) R-10, R-20, MH, PUD, or O-I zoning is required; (2) Location of the recreational vehicle shall be in the rear yard, unless evidence can be provided to the Administrator that size constraints or other factors prevent rear yard location. The specific restrictions and limitations are as follows: (1) When secondary to a primary residential use, the period of human habitation shall not exceed 14 days, and may not be re-established for a period of 90 days from the last day terminated;

(2) When construction or repair of a single family home occurs, the homeowner and his family may occupy a recreational vehicle for a period of 180 days. An extension to a maximum of 365 days may be granted by the Administrator upon presentation of evidence that construction cannot be completed within 180 days due to factors beyond their control. All occupied recreational vehicles shall maintain an adequate disposal system and a source of potable water. Emptying of wastewater disposal systems shall be done in accordance with Section 4.1 of the City of Southport Sewer Use Ordinance.

Note 14. Marina/Marina District. Single-family, two-family or multiple-family dwellings are prohibited uses on marinas located either on state property under NCGS 160A-392 or located on city-owned property.

The purpose of this note to the Table of Permitted Uses is to protect the character of the commercial development of this area and to reserve an area along the waters edge for maritime uses, water dependent uses, and water oriented uses. This is consistent with Southport's historical character as a working waterfront community open for all the public to use. This note also provides for certain other non-water dependent uses which are closely aligned with water oriented uses. Land uses which would legally or physically prevent the public from access to public trust waters are specifically prohibited. Residential, "dockominium" use (the sale of boat slips), and floating homes in this area are expressly prohibited.

This area is established to provide land for the use by all of Southport's citizens, visitors to the area by land or by water, and to support the city's tourist industry. Specifically, on city property or property regulated by NCGS 160A-392 the following shall be allowed:

- Bait and tackle shops
- Boat and other marine related offices
- Boat docks - public and for marina lease only
- Boat dry storage
- Boat ramps and boat launching facilities (including public)
- Boat repair facilities
- Boat service areas
- Boat safety and towing facilities
- Boat storage and boat construction yards
- Bulkheads and other shoreline stabilization
- Commercial charter or sightseeing water craft facilities
- Fishing piers and public boardwalks
- Launderette, coin operated laundry for marina uses, accessory to marina operation
- Marina

Marine related service and filling stations  
Marine equipment stores  
Mooring piles  
Navigational markers  
Parking areas - vehicle and boat trailers  
Parks and public use areas  
Public utility buildings  
Public water access  
Restaurant as an accessory use to marina operation

All setbacks must comply with CAMA and Corp. of Engineers requirements.

Except for Dockmaster's office, roofs, shelters, framing, or other similar elevated structures are not permitted over dock areas. Temporary, removable canopies are permitted to provide outdoor dining protection at restaurants.
