1. Development Director Travis Henley called the meeting to order at 4:05 pm

- 3. Introduction of Staff and Commission Members.

4. Nomination of Chair

6. Rules of Procedure – Discussion and Considerations

The Commission discussed and reviewed the Rules of Procedures implemented by the Historic Preservation Commission of the City of Wilmington. There is consideration for adopting similar rules of policy and procedures outlined in their guidelines. The Commission and Staff went through Wilmington's rules of procedure. Staff will work on drafting language that will be specifically tailored to the unique character of Southport and to the preservation of the designated Historic Districts.

7. Next Steps

Mr. Henley proposed that the Commission, along with Staff Members, consider visiting one of Wilmington's meetings and reviewing their minutes to help understand the process. Another option would be for Wilmington Staff to visit the Southport area for suggestions and recommendations.

The overall goals of the commission should come before the landmark designation discussion.

Chair Drew asked if there were any public comments: There were none.

He questioned if anyone was aware of what kind of project was being done at 113 E Bay Street. It was confirmed that it was just a remodel.
